In order to be “in good standing” active members must be current with their dues, attend 2 meetings, and participate (by serving as Trialsmaster, Assistant Trialsmaster, Observer, or competing) in 3 events, during the previous 12 months. NTTA members must support the NTTA at NTTA events and activities [*b. Membership, Article 4*].
- ❖ Per the by-laws, Proxy voting for any or all Club Officer position is allowed for Club Elections. The proxy vote must be submitted to the current Club Secretary in a sealed envelope prior to the Election night meeting – personally delivered or mailed [*c. Club Officers, Article 14*]. - ❖ The 2012 **Outdoor Motocross** season is wrapping up. Ryan Dungey made history this year by being the first KTM rider to get a 450 MX Championship. He wrapped up his championship with two races left by going 1-1 at Unadilla. In the 250 class, there are only 28 points separating 1st-3rd going into the last two races between Blake Baggett, Justin Barcia, and Eli Tomac. Ken Roczen was able to take his first moto win at Unadilla with KTM teammate Marvin Musquin taking the Overall. Unadilla was a great race for KTM sealing the 450 Championship, taking a 1st in Moto1 250, and Overall in the 250 class. KTM has built an incredible team with “The Man” Roger Decoster, Dungey, Roczen, and Musquin...now if they would only build a Trials bike! - ❖ The 2012 **MotoGP** season has been full of injuries. With seven races left, Jorge Lorenzo is leading the championship. At qualifying in Indy, American riders Ben Spies and Nicky Hayden both crashed. Second in points, and retiring at the end of this year, Casey Stoner also took a bad crash at Indy. Stoner and Spies were able to race on Sunday. Spies had more bad luck with his bike blowing up. Stoner was able to put in a solid race and finish 4th, however, he announced that he will be out for this week’s Brno race due to needing surgery on his ankle to avoid any permanent injury. James Ellison is still working strong trying to get the top CRT spot. This was his first time ever to ride Indy, and after getting a great start, he dropped back to 20th with some electrical issues.
